Matters Arising

[1.1] The clerk reported that PCSO Ceri Evans was unable to be present at the meeting and that the following information had been received;

[a] A quad bike had been stolen from a local farm, along with items from vehicles from within the community.

[b] The police are continuing to monitor the EVO triangle. Further information is available regarding prosecutions from the North Wales Police website.

[1.1] Public Footpath no 51 [Llwybr Bach]

Noted the response from Heledd Jones Natural Resources Wales advising that a site visit was to be arranged along with a discussion with Conwy CBC.

[1.2] Cae Llwyd

Clerk to contact Conwy CBC regarding the following;

[a] A “no dogs” sign is required on the gate facing the Cae Llwyd estate.

[b] Signs have been erected on the inside of the gate rather than the reverse side on the entrance.

[c] The matting beneath the play equipment is in need of attention.

[1.3] Defiliberator/Pentrellyncymer

[a] Einion Edwards explained that sufficient money had been collected to purchase a defiliberator for the village and that the money is to be deposited temporarily in the Community Council account to meet the cost of installation etc.

[b] Prys Ellis agreed to enquire regarding a similar arrangement for Cefn Brith.
