Matters Arising

[1.1] Police Matters

No Police presence.

[1.1] Trees at the Church Cemetery

Noted that the matter was ongoing.

[1.2] Grip Kinetin/ Housing Matters Cerrig-y-Drudion

Mr Arfon Hughes was welcomed to the meeting and referred to his report on housing needs in the community. Mr Hughes agreed to make further enquiries regarding tenants who wished to exchange their tenancy for larger or smaller accommodation.

[1.3] Innogy Wind Farm

[a] Members agreed to complete the questionnaires on an individual basis.

[b] Cadwyn Clwyd Brenig Wind Farm– Clerk to enquire regarding possible a financial contribution to the Community Council

[1.4] Pentrellyncymer Bridge

Noted disappointingly that the repair work required was still outstanding and that it was included in the programme of work by Conwy CBC.

[1.5] London House

Noted that Conwy CBC was arranging to erect a sign to alert motorists that pedestrians were crossing the road at this location.

[1.6] Traffic Speed Sign/King Street

The clerk reported that the County Council had advised that the flashingspeed traffic sign on King Street could not be relocated opposite the school given the introduction of the new speed limit. The cost of a new sign is apparently in the region of £1500.00. Clerk to enquire with NRW whether they are prepared to consider a contribution towards the cost.
